- 1) If the original driving licence cannot be submitted due to loss, an attest in a statutory declaration is to be made at the driving licence authority or to a notary or a police theft report is to be submitted.
- 2) for taxis a certificate for a successfully passed local knowledge test must also be submitted
- 3) submit certified translations of the foreign driving licence (except EU driving licence)
- 4) the holder of a paper driving licence which was not issued in Leipzig also requires a copy of the index card of the public authority which issued the paper driving licence
- 5) prerequisite is the possession of an EU driving licence card
- 6) in addition for cases of accompanied driving from 17 years of age: agreement of the parents and declarations of consent and a copy of the driving licence (front and back) of each accompanying person.
- 7) First aid training covers 9 teaching units. Certificates for 8 double lessons or 16 teaching units are still recognised. Certificates for instruction in immediate life-saving measures (8 teaching units) are no longer recognised.
